- 2.1.3.1.1. A Group must send representation to 2 consecutive Regular Monthly BHASC Meetings and agree to abide by the 12 Traditions of Narcotics Anonymous. The Group will be added to the BeeHive Area as of its 2nd BHASC attendance (Meeting List(s), Announcements, etc).
- 2.1.3.2. POLICIES REGARDING GROUP REPRESENTATIVES
- 2.1.3.2.1. A GSR/ Alt. GSR may not hold a position on the Administrative Committee of the BHASCNA.
- 2.1.3.3. REMOVAL FROM BEEHIVE AREA
- 2.1.3.3.1. The BHASC may remove a Member Group via a vote under either of two (2) conditions: 1). the Group ceases to hold meetings; or 2). the Group may be removed with a 2/3 majority of the Voting Members of the BHASC, if following repeated guidance from the BHASC, the Group continues to blatantly and repeatedly violate the 12 Traditions of Narcotics Anonymous.

2.1.3.2. POLICIES REGARDING GROUP REPRESENTATIVES
